

# ADOLESCENT HEALTH INITIATIVES

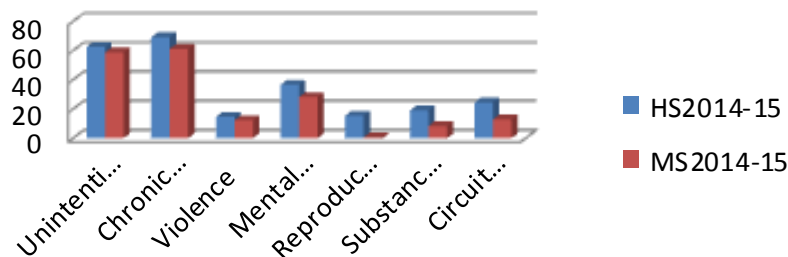
## SUMMARY

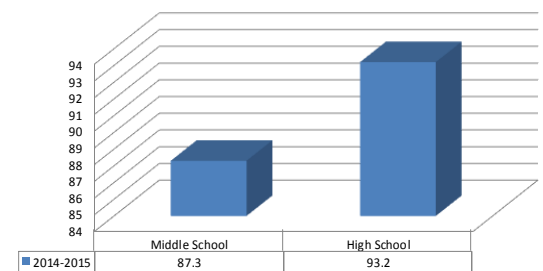
## HIGHLIGHTS

High Risks are identified by each student completing an adolescent high risk assessment. A "Circuit Breaker" indicates that there is potential for immediate harm.

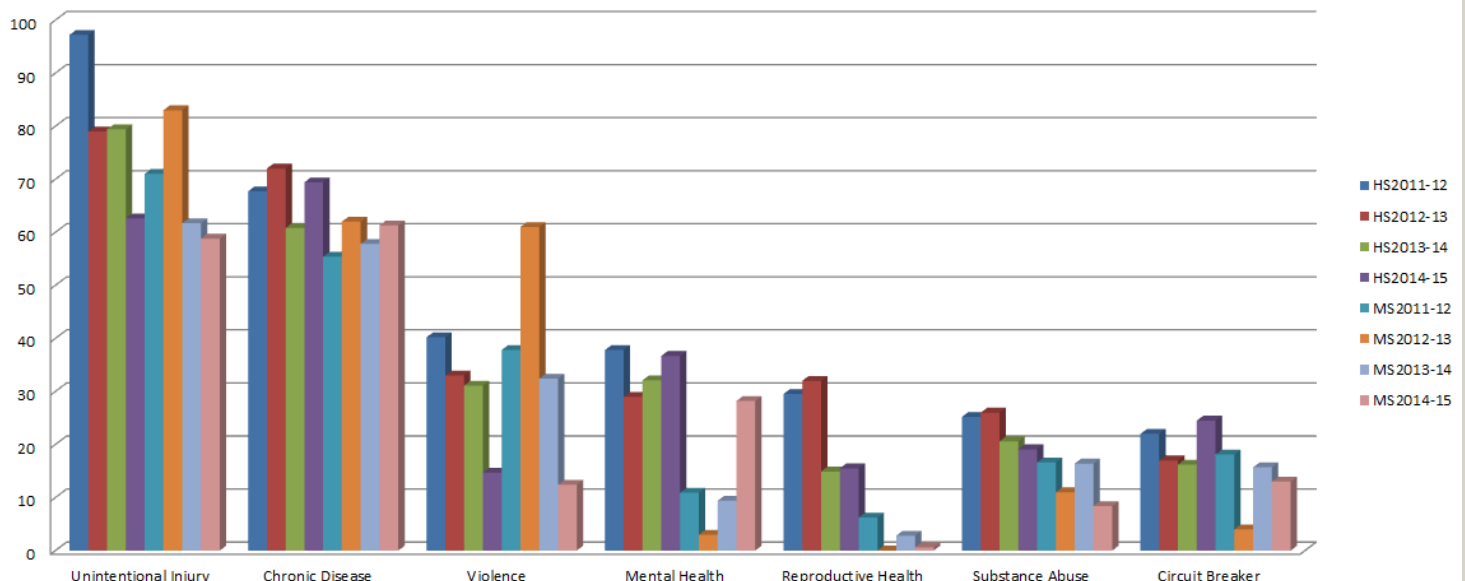
### 2014-2015 Percentage of Students Meeting Definition of High Risk by...
